In accordance with Regulation 8(c) of the Retirement Benefits (Occupational Retirement Benefits Schemes) Regulations 2000, as read with Clauses 11(i), 12 and 14 of the Trust Deed and Rules dated 13<sup>th</sup> February 2018, notice is hereby given of the upcoming election of Member Nominated Trustees for the Kenya Ports Authority Retirement Benefits 2012. The date set for the elections shall be 30<sup>th</sup> November 2023.

## **ELIGIBILITY GUIDELINES**

Interested candidates must meet the following **MANDATORY** guidelines:

- a) Must be a Member of the Scheme.
- b) Must have a minimum of O-level Certificate, Form Four Certificate or its equivalent.
- c) Must be able to read and write in either English or Kiswahili.
- d) Must present with the Application a Police Clearance Certificate from the Directorate of Criminal Investigations.
- e) Must provide a report from an approved Credit Reference Bureau.
- f) Must pass a fit and proper test in accordance with the attached template marked *Appendix 1*.
- g) Must be nominated by at least one hundred (100) Members of the Scheme who must give their names, check numbers/pension numbers and signature.

### Eligibility to vote: -

In order to be eligible to vote, one must be a member of the scheme.

**NB:** Members of the Scheme who serve on the Election Committee and the Dispute Resolution Board are NOT eligible to nominate or propose candidates, but they are permitted to vote.
